

# Financial Wellness Coordinator - Vehicle Repair

As the **Financial Wellness Coordinator – Vehicle Repair**, you will be responsible for coordinating and implementing the Car Repair program done through the oversight of case management and/or assessment. This position also oversees the direct services to improve participant financial wellness and stability.

Location: CAP-HC is based in St. Louis Park, MN and serves all of Hennepin County

### Responsibilities

#### General:

- Develop program guide deadlines with Client Services Supervisor
- Define annual and quarterly strategy based on budget, with Client Services Supervisor
- Create relationships with auto shop vendors
- Guide applicants through auto shop selection and estimate approval
- Manage check disbursement to applicable auto shops
- Complete Individual Employment Plan for participants utilizing DEED funds for car repairs
- Create and maintain participant files for accuracy
- Screen applicants to determine program eligibility
- Orient participants to ensure understanding of program requirements and support accurate completion of application and forms
- Manage applicants through intake process and submit applicants for approval
- Manage waiting list, as needed
- Develop and maintain relationships with stakeholders that support the goal of the program
- Connect participants to other resources within the agency and community

### Other:

- Support community outreach and marketing for education workshops
- Support fix-it minute clinics offered through partner auto body shops
- Maintain accurate and complete records to track and report outcomes
- Complete data entry for CAP 60, Workforce 1, or other client management database systems
- Work with federal and state administrator to ensure successful program implementation
- Perform other duties as assigned
- Cooperate with all staff members and assists with program services as requested
- Serve as agency representative to community organizations as requested and assigned

## **Skills Requirements**

- Demonstrated experience providing case management, including assessment skills and developing action plans
- Experience facilitating adult education/training in a group setting
- Professional and/or lived experience working with diverse communities and/or households defined as low income
- Experience balancing multiple projects requiring high attention to detail, strong organizational skills, and ability to prioritize
- Demonstrated interpersonal skills, including collaborating with a team, working across program areas, disseminating information effectively, and conflict resolution
- Effective verbal and written communication skills required, including public speaking skills



 Experience using Microsoft Office programs including Word, Excel, and PowerPoint at a proficient level, and with data management software programs or databases

- High school degree with 3 years of related experience or an equivalent combination of education and experience to successfully perform the duties of the job

- Fluent in English, as well as Spanish or Somali (Preferred)
